OBJECTIVE:

We, Natural Remedies Pvt Ltd, consider your privacy as very important to us. Our Privacy Policy has stipulated guidelines to ensure your privacy is protected.

SCOPE:

The following guidelines ensure that the information we collect about you are not misused
